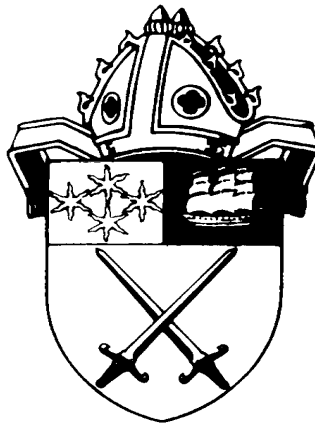

Bishop-in-Council is the Standing Committee for Synod.

Retiring members are eligible to stand for re-election.
